What is the overall deductible?	\$450 / individual or \$900 / family in-network. \$5,600 / individual or \$11,200 / family out-of- network.	Generally, you must pay all of the costs from <u>providers</u> up to the <u>deductible</u> amount before this <u>plan</u> begins to pay. If you have other family members on the <u>plan</u> , each family member must meet their own individual <u>deductible</u> until the total amount of <u>deductible</u> expenses paid by all family members meets the overall family <u>deductible</u> .
Are there services covered before you meet your <u>deductible?</u>	Yes. In-network <u>preventive services</u> , outpatient hospital services, inpatient hospital services, most <u>physician services</u> , some pediatric dental services and drugs are covered before you meet your <u>deductible</u> .	This <u>plan</u> covers some items and services even if you haven't yet met the <u>deductible</u> amount. But a <u>copayment</u> or <u>coinsurance</u> may apply. Are there other <u>deductibles</u> for specific services?	No.	You don't have to meet deductible for specific services.
What is the <u>out-of-</u> <u>pocket limit</u> for this <u>plan</u> ?	For in-network \$2,350 individual / \$4,700 family.	The <u>out-of-pocket limit</u> is the most you could pay in a year for covered services. If you have other family members in this <u>plan</u> , they have to meet their own <u>out-of-pocket limits</u> until the overall family <u>out-of-pocket limits</u> has been met.
What is not included in the <u>out–of–pocket limit</u> ?	All out-of-network <u>cost sharing</u> amounts ( <u>deductibles</u> , <u>copays</u> and <u>coinsurance</u> ), <u>premiums</u> , <u>balance-billing</u> charges, healthcare this plan doesn't cover, and <u>specialty drug</u> coupon programs payments. Exceptions include out-of-network medical <u>emergency</u> <u>services</u> (including mental health and substance abuse) and out-of-network air ambulance services.
